Hudson, a senior at Aledo High School, was severely burned in an accidental fire on Nov. 25 and is still in a fight for his life. His medical bills continue to mount and members of the community continue to help.

"As a parent, when you hear about an accident that involves a child, you immediately hurt for that child and their family," Evans said. "We wanted to help Cameron's family any way that we could."

Evans created a "Flip-A-Thon" for the center's opening day, as well as other fundraising efforts over the past few weeks. They successfully raised \$1,284 during their campaign, which was presented to Cameron's mother, Melissa Cannon.

"Most of (the money) was raised during the Flip-A-Thon," Evans said. "These young athletes were very excited to be flipping for a local family in need!"
